Music Portfolio Requirements

The portfolio must consist of 3 items:

- 1. Personal Statement
 - Write a personal statement (500 words or less) describing your interest in music, how this interest has been developed, and how you hope to contribute to the school community through your musical talents. Please save this document with the filename format: <Name>_Personal Statement
- 2. Recommendation Letter
 - Obtain a recommendation letter from a music teacher, preferably your current private music teacher. This letter should be written within three months of your DSA application. Please save this document with the filename format:
 <Name> Recommendation
- 3. Top Five Music-related Awards, Achievements, or Certifications:
 - Provide your top five music-related awards, achievements, or certifications you have achieved in the last three years. Examples include ABRSM certification, an award received at a national or international music competition, or participation in a music event. Please save this document with the filename format: <Name>_Certificate 1, <Name>_Certificate 2, etc

Submission Guidelines

- Save all submission files in PDF or JPG/PNG format according to the specified filename formats.

- The submission deadline is on 20 Jun 2024 (Monday) by 9.00am.
- Late submissions and appeals will not be considered.
