## CONSTITUTION OF OLD RAFFLESIANS' ASSOCIATION (extracts)

## Article 5 Ordinary Membership

This category shall be open to all graduates of the Raffles' Family provided they are not currently attending secondary schools, centralised institutes or junior colleges. A Member on becoming a student at an institute of higher learning shall, ipso facto, cease to be an ordinary member during the period of his/her studies.

#### Article 8 Associate Membership

Students of institutions of higher learning who are graduates of either of the schools in the Raffles' Family are eligible for Associate Membership provided always that they are not currently attending secondary schools, centralised institutes or junior colleges. An Associate Member will cease to be such once he leaves such institutions or 5 years from the date of being accepted as an Associate Member. The Council may thereafter extend the Associate Membership on a year to year basis.

#### MEMBERSHIP FEE

#### Article 11 Membership Fee

There shall be a one-time membership fee of S\$300 for Ordinary Members (subject to Article 12) and no membership fee for Associate Members. There is no subscription fee to be levied on either of the membership.

#### Article 12 Members above the age of 55

Graduates of the Raffles' Family who are of age 55 and above at the time of their applications for membership shall pay a discounted membership fee of \$150. Such discounts shall be given on valid proofs to age being produced to the satisfaction of Council, whose decisions shall be final.

## Article 13 Payment of Membership Fee

Unless otherwise provided, the sum of S\$300 (or S\$150 in the case of an applicant of age 55 and above) shall be paid in full immediately by an applicant at the time of his application for membership as an Ordinary Member, subject to a full refund without interest by the Council should his application be rejected for reason other than late payment of membership fee. An applicant may apply to pay the membership fee in three (3) equal monthly instalments, without additional interest being charged, with the first instalment payable at the time of application. The second instalment shall fall due on the 30<sup>th</sup> day from the date of the first instalment. The third instalment shall fall on the 60<sup>th</sup> day from the date of the first instalment. The third incash, cheque, through electronic means or other means as prescribed by the Council. Membership fee after three (3) months from the date of his application for membership fee. An applicant who fails to pay the full membership fee after three (3) months from the date of his application for membership shall not be admitted as member. No refund shall be made for monies paid in the event of such a rejection of application of membership by the Council in accordance with this Article.
